Crane - CV

TLILIC0012 Licence to operate a vehicle loading crane (capacity 10 metre tonnes and above) (CV)



Course Delivery

FACE TO FACE - this is a private course for your group of min 4 to max 6 people and is delivered using your vehicle loading crane. Training can be delivered at your site providing you have adequate resources, or at our training centre in Wetherill Park.

Vehicle Loading Crane Trucks cannot be hired so no public courses are available at this time. If you do not have a group of 4-6 people, you could consider gaining a C2 licence instead. TLILIC3008 Licence to operate a slewing mobile crane up to 20 tonnes.

Course Duration

4 days (3 days training plus 1 day assessing)

(the course duration depends on group size and level of any existing skills and knowledge of participants)

Course Cost

\$1,500 per person **gst-free**

Course cost is based on minimum 4 to maximum 6 people per course.

[A SafeWork NSW HRW licence fee is additional and payable by each successful applicant at Australia Post Office].

Course Prerequisites

Participants must be over 18 years of age, be able to speak and understand English; understand technical concepts and mathematical equations; and provide 100 points of Identification as per SafeWork NSW requirements. If a participant fails to bring 100 points of identification a re-booking fee of \$100 will be charged for assessment to be re-scheduled.

How do I determine if my Vehicle Loading Crane has an over 10 metre tonnes capacity?

To calculate the metre tonne rating of your crane, you need to:

1. Refer to your crane's **load chart**.
2. Determine from the load chart the **MAXIMUM LOAD** your crane can lift.
3. Determine the **MAXIMUM RADIUS** it can lift the **MAXIMUM LOAD**.
4. Multiply together these 2 numbers (Metres x Tonnes)
5. If the answer is equal to or greater than **10**, then you require a license to operate your Vehicle Loading Crane.

Course Overview

This course and licence is a legal requirement for anyone who operates a vehicle loading crane (over 10 metre tonnes).

During this course, operators are trained and assessed against the High Risk Work Licensing requirements as per Work Health and Safety Regulations.

Course Content

- Compliance with WHS licensing legislation.
- Communicate and work safely with others in the work area.
- Risk assessment and management procedures (particular awareness of the risks associated with overhead powerlines/electrical cables, ground conditions, crane tipping and demolition sites).
- Pre-operational checks, positioning, stabilising, set up, operation, post-operational checks of a vehicle loading crane, lifting and transferring of loads within capacity of the crane.
- Techniques for estimation of load weights.

Course Outcomes

On successful completion of training and assessment, participants will receive a Statement of Attainment for TLILIC0012 Licence to Operate a Vehicle Loading Crane (capacity 10 metre tonnes and above), and will be eligible to apply for a National Licence to Perform High Risk Work (CV Class).

High Risk Work (HRW) Licences are valid for 5 years from the date of issue.

To receive a SafeWork NSW issued HRW licence, participants MUST lodge their licence application form at an Australia Post outlet together with a passport sized photo and pay the prescribed SafeWork NSW processing fee within 60 days of the final HRW assessment. Failure to lodge your paperwork on time will result in you being an unlicensed operator and further training and/or assessing fees will apply after the 60-day period.

Please refer to other relevant information on Dogging / Dogman licence requirements.

Gantry Crane (Pendant-Type)

TLID3043 Shift loads using gantry equipment



Course Duration

4 hours

Course Cost

\$1,650 per session (GST free)

*This course is **only delivered at your site** using your gantry crane equipment and the above cost is based on a group of up to 10 participants per session.*

Course Prerequisites

Participants must be over 18 years of age, be able to speak and understand English, understand technical concepts and provide suitable identification.

Course Overview

A National High Risk Work Licence is **not** required to operate a bridge or gantry crane that is controlled from the ground by a pendant and has three or less powered operations. However, in accordance with the WHS Act and Regulations 2011 under Primary Duty of Care, a PCBU must provide information, training, instruction or supervision that is necessary to protect all persons from risks to their health and safety arising from work carried out as part of the conduct of the business or undertaking.

Gantry crane training is a half day, nationally accredited course in the safe operation of a remote / pendant (or pendulum) operated gantry crane is provided at your site, using your equipment, for groups of up to 10 participants. Both theory and practical training is provided together with an assessment of participants' skills and knowledge.

Course Content

- Definitions and licensing requirements
- Pre-operational inspection and safety checks
- Hazard identification / Risk assessment
- Planning the lift
- Transferring the load
- Use of lifting gear
- Shutdown procedures
- Emergency procedures

Course Outcomes

All successful participants meeting the assessment criteria will be issued a Statement of Attainment - TLID3043 Shift loads using gantry equipment.

What is NOT covered in this course?

If your type of equipment has more than 3 powered motions or is a "cabin controlled" gantry crane, then your operator will require a CB licence to operate it. If "slinging" techniques are required to move a load, you will need a qualified dogman with a DG licence to sling the load. This course does not cover these requirements, but please contact us for or other course information should you need a CB or DG licence.

Refresher - Forklift

TLID2010 Operate a Forklift (Refresher Training)



Course Delivery

FACE TO FACE - at our site in Wetherill Park (see our course calendar for scheduled dates)

Course Duration

4 hours

Course Cost

\$1,200 per session (GST free) for a group of up to 6 people

Course Prerequisites

Participants must have a valid Australian High Risk Work forklift licence class LF.

Course Overview

Forklift refresher training is aligned to the accredited unit of competency TLID2010 Operate a Forklift and is a half day (approx. 4 hours) training session conducted at your site (or ours) for already licensed operators. Training sessions are for a maximum of 6 people per group. Operators attending a 'refresher' course **MUST** produce their current forklift licence and proof of identification on the training day. Training will not be conducted without such evidence.

If you do not have a valid forklift licence, you must enrol in a formal training course (TLILIC2001), delivered by a Registered Training Organisation (such as Cobra Training Services). When you have achieved sufficient skills and competencies, you will be eligible for a LF licence assessment by a SafeWork NSW qualified assessor.

Forklift refresher training should be conducted on a regular basis and is designed to update the operator's theory knowledge; refresh practical skills, and improve operating techniques/procedures on the forklifts.

Benefits of training include: reinforces safe work practices, provides updates and changes to legislation, increases productivity and bottom line and assists in minimising the risk of damage/injury to property and persons.

Course Content

- Revision of forklift operators' theory knowledge and practical skills
- Hazard identification and risk assessment – plan work
- Conduct routine checks – conduct pre and post operational checks
- Shift loads safely
- Shut down and secure forklift truck
- Assessment of the safe application of knowledge and skills to workplace tasks

RIIHAN309E Conduct Telescopic Materials Handler Operations



Course Delivery

Course Duration

6-8 hours*

*PLEASE NOTE: *Course duration may vary based on training group size, prior experience (if any) and the number of attachments you are being trained on.*

Course Cost

This course can be delivered at our site or yours.

*For courses conducted at **our** site, we will supply the Telehandler equipment (including fork tyne and crane jib attachments), and there is no minimum number of participants required to join a public course. See below for scheduled course dates and Other Important Information.*

*For courses delivered at **your** site, you must supply the Telehandler equipment (and attachments you wish to be trained on) and a minimum of 4 participants is required.*

Course Prerequisites

Participants must be over 18 years of age, be able to speak and understand English; understand technical concepts; and provide suitable identification. A forklift licence [LF] is desirable, but not essential.

Please note: Telescopic Handlers with greater than three tonnes lifting capacity and fitted with a crane jib attachment, require a High Risk Work licence to operate them in most states (Class CN, C2 or above). This course does not cover High Risk Work licensing. If you require a HRW licence to operate your telehandler combination, please advise us so we can book you into the appropriate course.

Course Overview

A telescopic materials handler or telehandler, is a mobile all terrain multi-purpose machine fitted with a variable height/reach telescopic boom and a lifting attachment. The most common attachment are forks, but telehandlers can be fitted with a variety of attachments for different types of loads.

Some other attachment types available are:

- Work Platforms
- Earth moving buckets
- Crane/Lifting Jibs

In NSW, a High Risk Work (HRW) Licence is not required to operate a Telehandler with fork attachments regardless of lifting capacity*, however in accordance with the WHS Act and Regulations 2011 under *Primary Duty of Care*, a PCBU must provide information, training, instruction or supervision that is necessary to protect all persons from risks to their health and safety arising from work carried out as part of the conduct of the business or undertaking. A Gold Card provides evidence of formal information and training for operators of telescopic material handlers.

Course Content

This course covers all aspects of operating a telescopic materials handler:

- Planning and preparing for operations.
- Conducting pre-operational checks.
- Operating the telehandler.

- Attaching, securing, lifting, carrying and placing materials and loads.
- Selecting, fitting and removing attachments.
- Relocating the telescopic material handler from one site to another.

Who should do this course?

The information in this course is appropriate for people operating telescopic materials handlers at worksites in:

- General and civil construction ? all fields.
- Surface Mining, drilling and extractive industries.
- Transport/warehousing/logistics and waste recycling/recovery.

Course Outcomes

Participants successfully meeting the assessment criteria will be issued a Statement of Attainment in RIHAN309E Conduct Telescopic Materials Handler Operations and a Telescopic Handler Association (TSHA) Trained Operator Gold Card for the type of Telehandler and attachments you have been trained in the use of.

Other Important Information:

This course is only conducted in English, no interpreters or translators are permitted.

Participants MUST wear their current work uniform or neat casual clothes suitable to a warehouse or construction environment and must also wear or bring STEEL CAP/SAFETY BOOTS OR SHOES (Entry to premises will not be allowed if you fail to bring/wear steel caps)

Participants may also bring their own hi-vis vest and hard hat if they have these items, otherwise Cobra will supply loan items for the course duration.

Course Duration:	4 hours

Other Info: This course is designed for operators of a vehicle-mounted loading crane with under 10 metre tonnes capacity, if your vehicle loading crane has over 10m tonnes capacity, you are required to hold a valid HRW crane licence either CV or above, which is not covered in this course. Please read the following documents regarding how to determine if your crane has an over or under 10 metre tonnes capacity and lifting gear and licensed Dogman requirements.

Do I need a High Risk Work Licence to operate my Vehicle-Mounted Loading Crane?

Multiply the SWL (t) x the working radius (m) for that SWL = metre tonnes from the centre line of slew to the centre line of hook. This calculation must be done for each safe working load (SWL) on the load chart. If any calculation equals 10 metre tonnes lifting capacity or greater, the crane operator will require a High Risk Work Licence. This accredited course structure is both specific to your particular model of equipment and to Elevating Work Platforms in general.

Cobra Training Services delivers regular public training courses for boom lift (under 11m), vertical and scissor lifts at our site in Wetherill Park on a weekly basis.

We can also provide this service at your site for groups of 6-8 people if you have your own appropriate EWP equipment and resources. We do not charge any call out fees.
